BAILII is the most popular free legal website for those in legal education!



BAILII is a non-profit making charitable trust which makes full text primary legal materials without charge on the Internet.




The website contains databases of decisions of the Privy Council, House of Lords and the Court of Appeal, the Scottish Court of Session and the Irish Supreme Court and other courts and tribunals, from recent years and leading cases from earlier years.

Case transcripts



There are options to search in a particular jurisdiction or tribunal. New cases are loaded on the day of release. Recent decisions, additions, new cases of interest and most-downloaded decisions are identified on the service.

The BAILII database contains all decisions of the Privy Council from 1860 onwards, selected historical decisions from 1809 onwards.



BAILII databases offer access to legislation for the UK, Wales, Scotland, Northern Ireland and Ireland as passed.






Contains treaty information provided by the Foreign & Commonwealth Office (FCO) as web documents in the BAILII search interface.
